Tir Natur Privacy Policy

Our privacy policy explains how we use personal data we collect. We are committed to ensuring the privacy of our supporters and visitors to our website.

What data do we collect?

Tir Natur collects the following data:

- Personal contact details such as name, title, addresses, telephone numbers, and personal email addresses or company email addresses where you work for an organisation.

How do we collect your data?

You directly provide Tir Natur with most of the data we collect. We collect data and process data when you:

- Use the Contact us page on the Tir Natur website
- Sign up to our Tir Natur newsletter
- Donate to Tir Natur via our website or Crowdfunder
- Use or view our website via your browser's cookies.
- Consent to having your image or video taken by filling our photography/video consent form.

Collecting information from supporters

If you make a donation to us, we use your data to process and acknowledge your donation and we may undertake due diligence in certain instances.

How will we use your data?

Personal information provided to us will be used for the purposes outlined at the time of collection or registration in accordance with the preferences you express.

Only after you have voluntarily signed up to our newsletter via our website or through becoming a Community Founding Member, we will send you a newsletter to your email.

You have the right at any time to stop Tir Natur from sending you newsletters. If you no longer wish to be contacted for newsletter purposes, you can click on the unsubscribe button at the end of a Tir Natur newsletter or contact us at team@tirnatur.cymru

How do we store your data?

We will retain your personal information for as long as necessary to fulfil the purposes for which it was collected or as required by law.

What are your data protection rights?

Tir Natur would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access - You have the right to request Tir Natur for copies of your personal data.

The right to rectification - You have the right to request that Tir Natur correct any information you believe is inaccurate. You also have the right to request Tir Natur to complete the information you believe is incomplete.

The right to erasure - You have the right to request that Tir Natur erase your personal data, under certain conditions.

The right to restrict processing - You have the right to request that Tir Natur restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to Tir Natur's processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that Tir Natur transfer the data that we have collected to another organization, or directly to you, under certain conditions.

Cookies

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology. For further information, visit allaboutcookies.org.

What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

- **Functionality** - Tir Natur uses these cookies so that we recognise you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.

How to manage cookies

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.

Privacy policies of other websites

The Tir Natur website can contain links to other websites. Our privacy policy applies only to our website, so if you click on a link to another website, you should read their privacy policy.
